

Glossary of Terms

In the NHS, we use lots of acronyms and it can often be a little bit of a shock to the system when starting a new role. We've put together this glossary of different terms and explanations of acronyms to help you understand a bit more about some more commonly used terms within the NHS and across the trust.

We've divided this glossary into two main sections:

- The first section details commonly used terms in medical/surgical notes at the Trust and are more clinical in their application. These can vary from Trust to trust, and, from feedback from some of our IMG doctors, can cause some difficulty at the beginning of a IMGs NHS journey.
- The second section includes acronyms that are you are less likely to come across in clinical notes but are important to understanding the workings of the trust and the NHS. We've added a column for this section that explains the terms and will give some context to each of the abbreviations.

If you find these lists useful, there are other further comprehensive online resources for abbreviations that are used within the NHS.

Abbreviation	Full Meaning	Explanation
AfC	Agenda for Change	The main pay system for NHS staff, excluding doctors, dentists and senior managers. Staff are grouped into pay 'Bands' depending on the skill set, experience and seniority.
AHPs	Allied Health Professionals	Health care professions distinct from optometry, dentistry, nursing, medicine, and pharmacy. There are <u>14</u> <u>groups of AHPs</u> that operate within the NHS such as paramedics, Physiotherapists, Speech and Language Therapists (SLTs) and radiographers.
ARCP	Annual Review of Competency Progression	ARCPs are the process by which doctors in training are appraised each year to ensure they are offering safe, quality care, and to assess progress against standards set in the curriculum for their training programme.
ANP	Advanced Nurse Practitioner	'Advanced Practice' is a level of practice, rather than a type or specialty of practice. Advanced practitioners are educated at masters' level in advanced practice and are assessed as competent in practice, using expert knowledge and skills. They have the freedom and authority to act, making autonomous decisions in the assessment, diagnosis and treatment of patients.
BMA	British Medical Association	The BMA is the trade union and professional body for doctors in the UK.
ССТ	Certificate of completion of training	A CCT confirms a doctor has completed an approved UK training programme and is eligible for entry onto the Specialist Register or GP Register. The Certificate of Eligibility for Specialist Registration (CESR) provides an alternative route to the specialist register for those doctors who have not followed a traditional training programme, but who may have gained the same skills as CCT holders.
CESR	Certificate of eligibility for specialist registration	CESR is a process to allow those not in training programmes and whose specialist training, qualifications or experience was partly or completely acquired outside of an approved CCT (Certificate of Completion of Training) programme to gain consultant status.
CoS	Certificate of sponsorship	The first step of obtaining the visa is to receive a Certificate of Sponsorship (CoS) from the hospital's HR team. For the hospital to receive a CoS, they must apply to the UK Visa and Immigration Department.
CPD	Continuing Professional Development	CPD is any learning outside of undergraduate education or postgraduate training that helps you maintain and improve your performance.

ΡΑ	Physician Associate	PAs are a group of allied health care professionals trained according to the medical model of care. They undertake a two year postgraduate course where they learn a systems approach to managing patients. They learn history taking, examination, formulation of management plans and can do procedures. Once qualified, a PA will gain enhanced skills within the areas they work, and partake in research, audit and projects. They cannot currently prescribe or order ionising radiation tests but this remit may change soon.
PACES	Practical Assessment of Clinical Examination Skills	PACES is a practical examination that is designed to test the clinical knowledge of trainee doctors hoping to enter into higher speciality training (ST3+).
PACS	Picture Archiving and Communication System	PACS is a medical imaging technology used primarily in healthcare organizations to securely store and digitally transmit electronic images and clinically-relevant reports.
PALS	Patient Advice and Liaison Service	PALS offers confidential advice, support and information on health-related matters to patients. They are also often the mechanism to which patients will compliment, feedback or complain about the service.
PCN	Primary Care Network	They are groups of primary care practices working together and with other local health and care providers (e.g., hospitals, mental health or community trusts, community pharmacies and charities) to provide coordinated care through integrated teams.
QI	Quality Improvement	The use of methods and tools to continuously improve quality of care and outcomes for patients.
SAS	Specialist, Associate specialist and Specialty Doctors	Specialty and Associate Specialist (SAS) doctors are non- training roles where the doctor has at least four years of postgraduate training, with two of those being in a relevant specialty.
SCC	Surgery, Cancer and Cardiovascular	One of our clinical divisions comprising services including: Surgery (General and Vascular), Oncology, Haematology, Trauma, Ophthalmology, Critical Care and Anaesthetics.
SHO	Senior House Officer	A physician employed at a level after full registration with the GMC and before entering higher specialty training – this is generally equivalent to F2 to IMT2 level.
SpR	Specialty registrar in a hospital specialty	A Doctor who is receiving advanced training in a specialist field of medicine in order to become a consultant in that specialty.
TPD	Training Programme Director	A senior doctor who has a broad responsibility for the running of a particular training programme at the trust.

ST1-8	Specialty Training (Grade 1-8)	ST is the final stage of becoming a fully qualified doctor within the UK and allows doctors to acquire expertise in a specialist area of Medicine or general practice. The first year of specialty training is termed ST1, the second ST2 and so on.
WCCS	Women's, Children's and Clinical Support	One of our clinical division comprising services such as Children's services (Neonatal and Paediatrics), Gynaecology & Reproductive Medicine, Maternity, Pharmacy, Imaging and Pathology (NWL pathology).
UTL	Unit Training Lead	These are senior doctors who have a broad responsibility to lead the educational activities within their speciality at Trust level.
